Thank you for taking the time to learn more about the Cultural Council. We're thrilled to share with you the highlights of another significant year of dedicated service to (and the accomplishments of) the invaluable cultural sector here in Palm Beach County.

In October 2021, we celebrated our return to in-person programs at the Cultural Council with *Gathering*, an exhibition dedicated to the joy of being together again! We also invited art-lovers to a new season of Solo Gallery shows, the first to be developed and chosen by competitive selection process intended to provide opportunities for creative professionals of any means, background, education, and age. At the end of 2021, we announced that the Artist Innovation Fellowship Program would be expanded to include funding for six fellowships in 2022. We invite you to explore the cumulative work of these talented Fellows (all female!) at the *2022 Artist Innovation Fellowship Showcase* from July 20 to September 9, 2023 at the Cultural Council.

We kicked off our 17th season of Culture & Cocktails at The Ben in Downtown West Palm Beach in January 2022, bringing back the art of cultural conversation to audiences after its all-virtual season in 2021. Later that month, we continued to expand our representation and celebration of all cultures and communities with the exhibition *Being Heard, Being Seen* featuring artists identifying as LGBTQ+.

As the county's sole support agency for arts and culture, the Council also took on the task of launching a needs assessment survey in the spring of 2022, which gathered results and feedback from our core constituents (Palm Beach County's cultural organizations and creative professionals). The data from this survey provided us with the information we need to best serve this incredible cultural community, as well as devoted supporters like you.

Though we are proud of the work we have accomplished this year—the truth remains that *all* of our success can be directly attributed to the support we receive from donors and members like you. Your donations provide critical operating support for programs, funding, and advocacy efforts that serve cultural organizations and help keep creative talent living and working in our community.

Thank you for taking the time to learn more about the work of the Cultural Council, and for your continued patronage. We hope to see you at one of our events or exhibitions this season, next season, and all the seasons yet to come.

# Grants

**\$4,644,867** in funding to  
**64** cultural organizations and  
creative professionals in  
Palm Beach County

The Council administers three county-funded grant programs. Categories B and C-II are supported by bed tax revenue in coordination with the Palm Beach County Tourist Development Council and are designed to support cultural tourism by funding marketing and program expenses associated with performances, exhibitions, and cultural events. Category C-I grants are funded by ad valorem tax and are designed to preserve cultural heritage through the arts and provide the opportunity for residents and students to experience diverse and innovative cultural programs and projects. The Council also administers three artist grant programs: the Artist Innovation Fellowship Program; the Dina Baker Fund for Mature Female Artists; and contributes to part of a multi-county arts initiative, the South Florida Cultural Consortium.

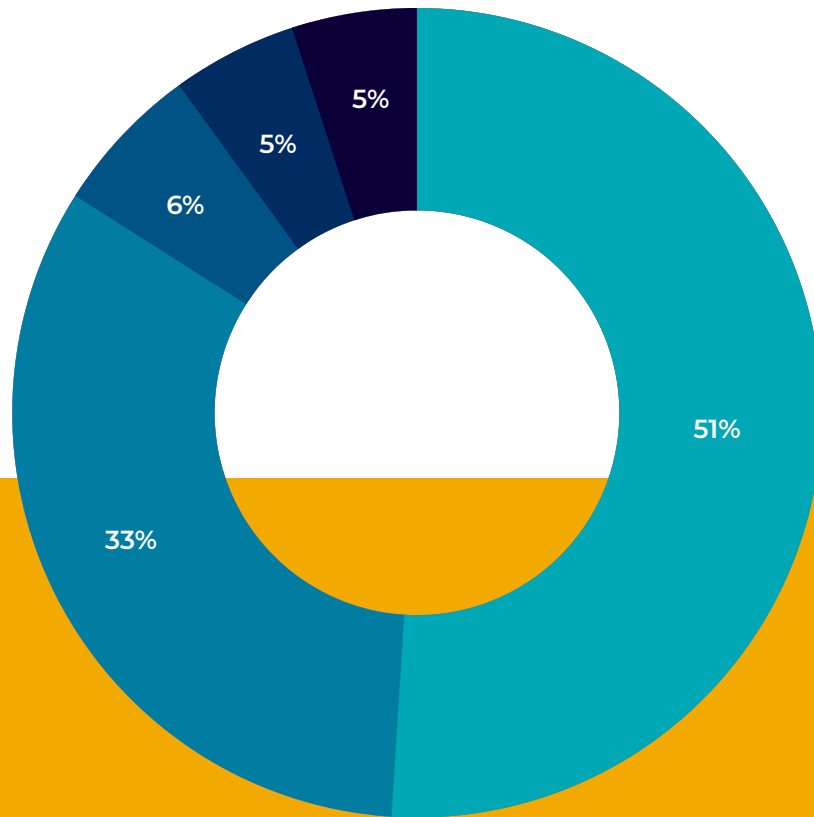

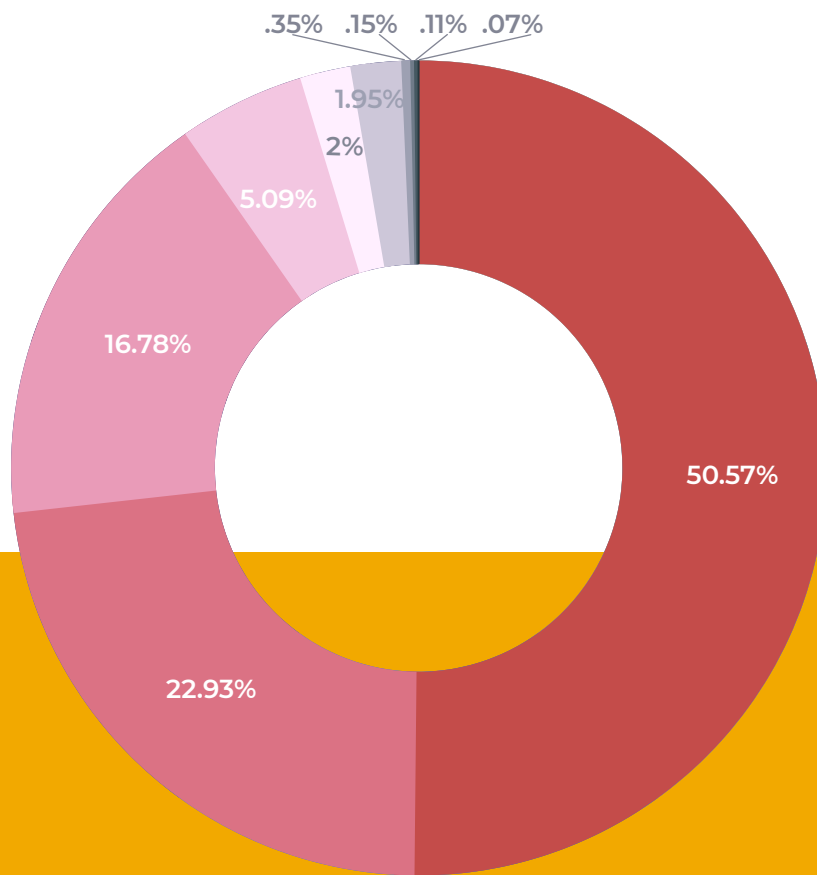
