



DEAR FRIENDS AND SUPPORTERS,

We're excited and honored to present the achievements of another impactful year, showcasing our unwavering commitment to supporting and celebrating the vibrant cultural community of Palm Beach County. In October 2022, we launched a new season of exhibitions at the Cultural Council with Contemporary Art of the Latin American Diaspora, an exhibition which showcased the diverse work and stories among Palm Beach County-based professional artists of Latin American and Hispanic descent.

We kicked off a new season of Culture & Cocktails at The Ben in Downtown West Palm Beach in November 2022, heralding an 18th season of culture, conversations, and community. Ringing in 2023, the Council unveiled its winter exhibition, Visualizing Climate Disruption, which offered more than 40 works from 17 artists who shared their unparalleled perspective of the constant changes within Palm Beach County's diverse ecosystem. This exhibition later traveled to Manatee Lagoon in Riviera Beach, and will be at the Miramar Cultural Centre in 2024.

On May 20, 2023, the Council held its first-ever Palm Beach County Open Studios event, inviting tourists and locals alike to visit more than 75 artist studios across the entire county to meet these creative professionals and see their work up-close. Launched in conjunction with the sixth annual Month of Shows, Art, Ideas, and Culture (MOSAIC), Open Studios was a wild success and will be expanded to two days in May 2024.

Emphasizing our support of Palm Beach County-based professional artists, the Council held its second Artist Innovation Fellowship Showcase in the summer of 2023, celebrating the six talented Fellows who completed their work in 2022. In 2024, we are delighted to continue this program with 10 all-new Artist Innovation Fellows and will spotlight their work in the summer of 2025.

The impact of the Cultural Council on the arts and cultural sector of Palm Beach County and its diverse roster of creative professionals is immeasurable. We are humbled and honored to serve this incredible community—but we cannot do it alone. It is only with your financial support that our initiatives flourish, enabling us to broaden our reach and deepen our impact. Together, let's build a vibrant and inclusive arts ecosystem for generations to come.

GRANTS

\$5,410,653 in funding to 63 cultural organizations and creative professionals in **Palm Beach County**

The Council administers three county-funded grant programs. Categories B and C-II are supported by bed tax revenue in coordination with the Palm Beach County Tourist Development Council and are designed to support cultural tourism by funding marketing and program expenses associated with performances, exhibitions, and cultural events. Category C-I grants are funded by ad valorem tax and are designed to preserve cultural heritage through the arts and provide the opportunity for residents and students to experience diverse and innovative cultural programs and projects.

The Council also administers three artist grant programs: the Artist Innovation Fellowship Program (granted every other year); the Dina Baker Fund for Mature Female Artists; and contributes to part of a multi-county arts initiative, the South Florida Cultural Consortium.






